Directions to Kolf Sports Center

From Highway 41, exit on Highway 21 East into Oshkosh (exit 119). Follow Oshkosh Ave over the Fox River Bridge to High Street (first stop light after the bridge). Turn right onto High Street (one way street). Kolf Sports Center will be located on your right-hand side. You may park in any of the parking lots near the building. Camp will be upstairs.

Walk-In:
Walk-in registration will be accepted at the door unless maximum limit of players is reached prior to camp date. Please contact if within a week of the camp date.

Cancellation Policy:

Your fee will be refunded without question if you cancel your enrollment two weeks prior to the first day of camp. Any time after this point, refunds will be made for medical reasons only. Requests for refunds must be in writing and accompanied by a signed excuse from a physician. Campers who must leave during the week due to illness or injury will receive a prorated refund based on the number of sessions attended. Requests for refunds must be made within three months of the conclusion of the camp.

Medical Release
