## **Head Coach—Scott Beyer**

## **Assistant Coach—Alyssa Doomis**

Coach Doomis is in her 2nd year as UWO's top assistant. She comes to UW-Oshkosh after a standout career as a catcher and third baseman at Trinity International University (Ill.) from 2015-18. Doomis helped the Trojans go from a 1-30 record during her first season to a 29-19 mark in 2018 and their first appearance in the eight-team National Christian College Athletic Association (NCCAA) World Series since 2007. Doomis was also a three-time NCCAA All-North Central Region selection.

## **Cancellation Policy:**

Your fee will be refunded without question if you cancel your enrollment two weeks prior to the first day of camp. Any time after this point, refunds will be made for medical reasons only. Requests for refunds must be in writing and accompanied by a signed excuse from a physician. Campers who must leave during the week due to illness or injury will receive a prorated refund based on the number of sessions attended. Requests for refunds must be made within three months of the conclusion of the camp.
